**PUBLICAÇÕES:** Relatório Anual da Administração, Demonstrações Financeiras relativas ao exercício social findo em 31/12/2013, acompanhadas das Notas Explicativas, Parecer da Ernst & Young Auditores Independentes e Relatório do Comitê de Auditoria publicados em 15/02/2014 no Diário Oficial do Estado de São Paulo (fls. 5 a 17) e no dia 14/02/2014 no jornal Valor Econômico (fls. B13 a B20).

**PRESENÇA:** Presentes acionistas representando mais de 33% (trinta e três por cento) do capital social votante e total da Companhia, conforme se verifica pelas assinaturas no “Livro de Presença de Acionistas”. Presentes, ainda, integrantes da Administração da Companhia e o Sr. Flavio Serpejante Peppe, representante da Ernst & Young Auditores Independentes.

**ORDEM DO DIA:** (1) Tomar as contas dos administradores, examinar, discutir e votar as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2013; (2) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31/12/2013; e (3) Fixar a remuneração global dos membros do Conselho de Administração e da Diretoria para o exercício de 2014.

**DELIBERAÇÕES:** Foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76:

(1) Aprovar, por unanimidade dos acionistas presentes, as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31 de dezembro de

2013, acompanhadas das Notas Explicativas e do parecer da Ernst & Young Auditores Independentes;

(2) Aprovar, por unanimidade dos acionistas presentes, a proposta de destinação da totalidade do resultado do exercício social encerrado em 31/12/2013, correspondente a R\$ 1.081.516.765,50, nos seguintes termos: (i) R\$ 865.213.000,00 à conta de dividendos obrigatórios, que após a compensação com os dividendos intermediários pagos com relação ao exercício de 2013, no valor de R\$ 669.510.000,00, e dos juros sobre capital próprio pagos com relação ao exercício de 2013, no valor de R\$ 50.000.000,00, restará um saldo a pagar de R\$ 145.703.000,00, o qual se propõe seja distribuído aos acionistas a título de dividendos, resultando no valor de R\$ 0,07847515 por ação (valor estimado, que pode ser modificado em razão da alienação de ações em tesouraria para atender ao exercício de opções de compra de ações outorgadas com base no Plano de Opção de Compra de Ações da Companhia e por eventual aquisição de ações no âmbito do Plano de Recompra de Ações da Companhia); e (ii) R\$ 216.303.765,50 para constituição da reserva estatutária para investimentos e composição dos fundos e mecanismos de salvaguarda da Companhia. Os dividendos serão pagos em 27 de junho de 2014, tomando como base de cálculo a posição acionária de 11 de junho de 2014. As ações da Companhia serão negociadas na condição “com” até o dia 11 de junho de 2014, inclusive, e na condição “ex” dividendos a partir do dia 12 de junho de 2014; e

(3) Aprovar, pela maioria dos acionistas presentes, a fixação da remuneração global anual da administração para o corrente exercício, no valor de até R\$ 5.967.000,00 para o Conselho de Administração e de até R\$ 18.085.000,00 para a Diretoria.
